In the autumn of 2022, the Polish-Hungarian Chamber of Commerce launched its **Student Mentoring Program**, in the framework of which participating students could take part in a study trip to Krakow and Katowice in Poland, between 16 and 23 November 2022.

During the study trip, the students visited several member companies of the Polish-Hungarian Chamber of Commerce, including <u>TriGranit</u>, <u>Mikulski & Wspólnicy</u> law firm, <u>Nowy</u> <u>Styl</u> and the <u>EXPO</u> in Krakow. The programme also gave the students the opportunity to learn about the <u>CED</u> Central European Economic Development Network and visit the Consulate General of Hungary in Krakow. During the second half of the study trip in Katowice, the group was hosted by the <u>Regional Chamber of Commerce in Katowice</u>, where they were introduced to their institution and had the opportunity to attend the Chamber's major event, the SME Congress.
