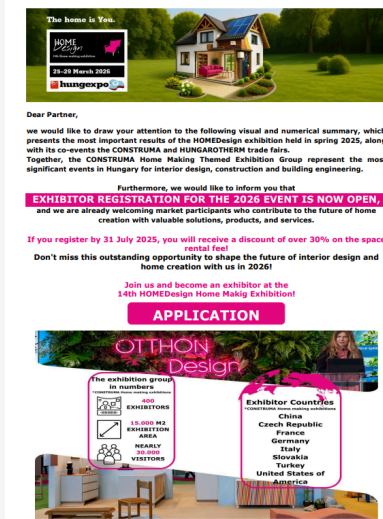

YOUR CEE LAW FIRM

The goal of the **Polish-Hungarian Chamber of Commerce** is to provide its members with up-to-date business information about the Hungarian market. In cooperation with our member company PETERKA & PARTNERS, we would like to draw attention to two important recent changes:

- Amendment of legislation on product liability

Software and digital manufacturing files will be treated as “products” for the purposes of strict liability — meaning manufacturers can be held liable without proof of fault for defects in such items. The new rules also make it easier for claimants to bring forward cases: for example, if a manufacturer fails to cooperate with requests for evidence, or if there’s an obvious malfunction, a rebuttable

presumption of defect or causation applies. Additionally, the limitation period for personal-injury claims is extended from 10 to 25 years, and the previous EUR 500 minimum threshold for property- damage claims has been removed.

- Significant judgment of Supreme Court of Hungary on rules of limitation

According to the Supreme Court, the rules of limitation are of fundamental importance and deviations from them by the parties cannot be recognized as valid. This is because a written request for performance is contrary to the purpose of the statute of limitations: rather than encouraging the enforcement of the claim, it prolongs the enforcement period and the uncertainty associated with it. Consequently, the parties may not deviate from the provisions governing the interruption of the limitation period in their contracts or individually-negotiated terms, nor can they broaden the scope of those provisions.
