The goal of the **Polish-Hungarian Chamber of Commerce** is to provide its members with up-to-date business information about the Hungarian market. In cooperation with our member company PETERKA & PARTNERS, we would like to draw attention to two important recent changes:

- Tax Changes Affecting Businesses from January 2026**

The 2025 autumn tax package adopted on 18 November, aims to reduce corporate tax burdens, simplify administration, and advance digitalization of tax procedures to support competitiveness and predictability for businesses, especially SMEs and sole traders in Hungary. It introduces new investment-focused tax incentives, raises the VAT exemption threshold for small taxpayers, and adjusts personal, social contribution and KIVA tax rules to ease tax liabilities and broaden eligibility. The package also includes measures to delay excise tax increases, modernize tax administration processes, and offer targeted incentives for energy-related investments.

- Hungary adopted a new national AI Act**

In 2025 Hungary adopted a new national AI Act to implement the EU Artificial Intelligence Regulation (EU 2024/1689) into domestic law. The new legislation took effect on 1

December, 2025. The law designates two primary authorities: the National Accreditation Authority as the AI Notification Authority, and the Minister of National Economy, as the AI Market Surveillance Authority, to oversee the compliance of high-risk AI systems and market surveillance and imposes substantial compliance obligations on any company that develops, integrates, distributes, or utilizes AI in Hungary. The law establishes the Hungarian Artificial Intelligence Council, which advises the government on national AI strategy, education, ethical frameworks, and cooperation. The provisions relating to the AI regulatory testing environment will enter into force on 2 August, 2026.
