The member company logo will be made available to our members after signing the Declaration. Having signed the forms, member companies may use the logo "Member Company of the Polish-Hungarian Chamber of Commerce".

- **the Chamber's institutional and corporate network contributes to provide for reliable and up-to-date networking and effective advocacy for our member companies in Poland and Hungary**

The Polish-Hungarian Chamber of Commerce is a member Chamber of the Polish Chamber of Commerce (KIG www.kig.pl), and is therefore able to provide contacts with all sectoral and regional chambers in Poland.

The Polish-Hungarian Chamber of Commerce is an accredited bilateral chamber of the Hungarian Chamber of Commerce (www.mkik.hu) and works in cooperation with the International Directorate of MKIK.

The Chamber has signed a cooperation agreement with the Polish Agency for Investment and Trade Promotion (PAIH), with which it jointly organises its events in Hungary, and we also cooperate in our events in Poland www.paih.gov.pl.

The Chamber cooperates with the Hungarian CED Central European Economic Development Network (www.ced.hu).

The Chamber cooperates with diplomatic bodies in Poland and Hungary.

The partner institution of the Polish-Hungarian Chamber of Commerce is the Chamber of Commerce and Industry in Katowice (www.rig.pl), which is the largest chamber association in Poland with more than 700 Polish member companies and a significant potential for networking.
